Kindly provide me Information for the below requests. 1. I would like to know how much value has been recovered for the above passed order ? 2. Is [REDACTED] a personal Guarantor in this case or not?

3. [REDACTED] [REDACTED] who used to reside at [REDACTED] [REDACTED] is the 4th defendant in this case, Why his personal property mentioned in the case i.e. the above address not been attached by the financial institution IFCI till today?
I would like to know the information of the above questions as I am one of the partner's son namely [REDACTED]. It has come to my notice that [REDACTED] has debt and for the same reason all his legal heirs are engaging in a spree to sell the personal properties of [REDACTED] [REDACTED] [REDACTED] is a partner in national Hotel and also has his residence at the above mentioned address. I have also furnished the Death Certificate and legal heir certificate of [REDACTED] as he had demised on [REDACTED] in the attachment. As I am learning to file the RTI Application I am unaware of the process that I have to establish my relationship in this particular case. I have hereby attached the appropriate documents in the attachments so that my application does not get rejected under RTI Act 2005 section 8,1,j. (Reason for 1st appeal is due to the request made for the 3rd question) the above mentioned property of [REDACTED] [REDACTED] is it given as a guarantee by the guarantor or not ? my objective is to get information and im not seeking explanation regarding the property.
