Text of RTI First Appeal :	<p>That vide email dated 20.12.2022, request was made to HR Department/Mumbai Regional Office to kindly book/allot one room in IFCI's Guest House situated at: Santacruz West, Mumbai, for my Guest (Friend). The details w.r.t same were attached along with the said email i.e. in the Scan copy of the Filled in Requisition Form for Guest House. In line with HR Department's email dated 22.09.2022, w.r.t the requests for booking of all VoFs/Guest Houses maintained at various locations by IFCI, the above mentioned email was also sent at the email address: vof@ifcilt.com. However, since, no response was received, accordingly, vide another email dated 20.12.2022, Mumbai Regional Office was once again requested for booking/allotment as mentioned above in line with: As per Delegation of Powers-Estates & Security Department [vide HR Circular No. 2022/10/HR/018 dated 04.10.2022], S. No. 5 (e): Approval for allotment of Flat/VoF/Dormitory – Competent Authority is: GM (At HO)/ RO Head (Not below GM) at RO. Subsequently, vide revert email dated 20.12.2022, GM/RO-Head (Mumbai) informed that: VoF/ Guest House booking is being taken care by HR Deptt.</p> <p>And I may be in touch with DGM-HR.</p> <p>After booking confirmation from HR, the handover of key shall be done by Mumbai Regional Office. Thereafter, the said email from GM/RO-Head (Mumbai) was forwarded to HR Department on 20.12.2022 itself. However, no response was received from HR Department. As such, i was left with no other option, but to seek information by filing RTI dated 20.12.2022, requesting to provide the name of the concerned department of IFCI Ltd. which deal with the</p>		

booking/allotment of VOF/Guest House at Head Office of IFCI Ltd. & its Regional Offices. However, despite lapse of the time limit, no response has been provided to me w.r.t the said RTI Application dated 20.12.2022. Hence, the present First Appeal.
