Text of RTI First Appeal (आरटीआई प्रथम अपील का पाठ) :	In response to my above RTI application, the CPIO, IFCI has purportedly sent me the copies of HR circulars pertaining to payment or reimbursement of the allowances, perquisites, reimbursements, advances etc. issued by IFCI during the years 2019, 2020, 2021, 2022 and from 01.03.2023 till date along with his letter No.230313006 dated 10.3.2023. However, copy of none of the circulars mentioned in the said letter of CPIO, IFCI has been found attached with the aforesaid letter. There is no sign or hole of the staple pin on the letter nor is there mention about the number of documents enclosed with the said letter. I had also brought the		

fact of non receipt of the copies of the circulars to the notice of the CPIO vide my Email dated 16th March, 2023. Since the requisite information sought for by me has been denied, I hereby submit my first appeal for your kind consideration and orders.

You are therefore requested to kindly advise the CPIO, IFCI to make available to me copies of all the HR Circulars and the Office Orders pertaining to payment or reimbursement of the allowances, perquisites, reimbursements, advances etc. issued by IFCI during the years 2019, 2020, 2021, 2022 and from 01.03.2023 till date.
