This is an order on your RTI appeal No. IFCIL/A/E/22/00005 dated 06/05/2022 against the CPIO response dated 06/05/2022 in respect to your RTI Application No. IFCIL/R/E/00019 dated 19/04/2022.

The appeal alongwith the response given by CPIO based on the information given by Department concerned was perused. The appeal was then forwarded to the concerned Department for their comments.

After perusal of the information given by the Resources Department, your appeal is disposed off as under.

1. In respect to the para 1 of your appeal alleging the part information, it is stated that the CPIO has rightly denied the information in view of the Sec 8(1)(j) of the RTI Act, 2005 being the personal information of the said investors.
2. In respect to para 2, the department has informed that the cheques were dispatched as per the details already shared by CPIO, which were not returned undelivered to IFCI. The proof of dispatch is also being shared herewith. However, as the cheques were not presented for payment and amount is lying unpaid, CPIO has already advised you to update your present/correct bank details and address with your depository participant in respect of your Demat account number.

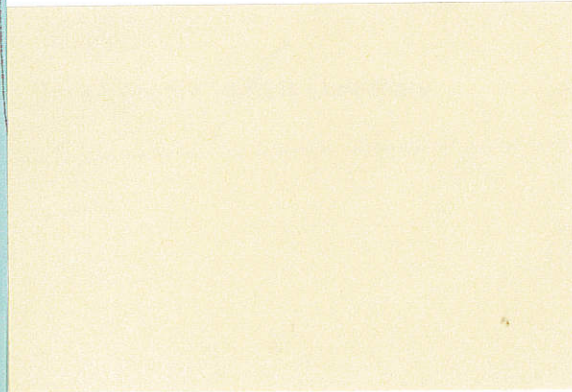
In view of the above, the Undersigned as First Appellate Authority doesn't find any merits in your appeal and the same is dismissed.
