ORDER

This is an order on your RTI Appeal dated 10/09/2020 preferred against the response to your RTI Application dated 05/08/2020 which was disposed of by the CPIO vide reply no. IFCI/RTI/840/2020 dated 26/08/2020.

2. The undersigned as FAA has considered the grounds raised in the present appeal and point wise disposal of the appeal is as under:-

- i. In reference to objections raised in the serial no. (i) of your appeal, the Concerned Department i.e. Human Resources Dept. was advised to re-check the information provided to the CPIO on the basis of facts mentioned in your present appeal as well as subsequent email dated 10/08/2020. The said Dept. had on re-verification confirmed that inadvertently some discrepancies have been crept into the details provided to the CPIO which reproduced as under:-

"regarding year-wise number of promotions granted by IFCI to its employees of different ranks during the period between the year 2010 and the year 2020 (upto 31st July, 2020) i.e. promotions made, the row reflecting details pertaining to promotion for year 2014 was inadvertently left blank."

The concerned officials of Human Resources Dept. has been advised to be vigilant in future in furnishing the information w.r.t. RTI Applications. Further, since the rectified details have been provided by the concerned dept., the same are being provided to you directly. The details w.r.t. query no. 1 as shared by the said dept. enclosed as Annexure A appended with the present letter.

- ii. In reference to the objections raised in serial no(ii), it is retreated that only the information which is existing in the records or held by the Public Authority is required to be provided to the information seeker. The CPIO has dully provided the information sought by you and no further action in this regard is required. Further, the CPIO is also not supposed to create information or to interpret information or to solve the problems raised by the applicants or to furnish replies to hypothetical questions. The Objection raised in the serial no. (ii) of the appeal is disposed of, accordingly.
- iii. In reference to the objections raised in serial no.(iii), the CPIO has provided the information qua the pay scales applicable to the different scales of the officers and the same has been disclosed by the Public Authority as per the provisions of Sec 4(1)(b) of the RTI Act, 2005. However it has noticed that the details of the gross emoluments being paid to the officers having different scales have not been disclosed in the website of IFCI Ltd. as per the provisions of said act. Accordingly, the concerned department has been advised to declare the details of gross emoluments as per the provisions of Sec 4(1)(b) of the RTI Act, 2005 at the earliest. Further, considering the fact that IFCI Ltd. is working with limited man
