- (iii) Place for submitting bid : To be dropped at the Tender Box kept at 9<sup>th</sup> floor, Earnest House, Nariman Point, Mumbai- 400 021. The cover of the bid document should be prominently super-scribed with the words "**QUOTATION FOR PURCHASE OF IFCI OWNED CAR (SKODA SUPERB-1.8TSI)**".
- (iv) The Bid(s) shall be opened on 6<sup>th</sup> April, **2018** at **5.00** pm at 9<sup>th</sup> Floor, Earnest House, Nariman Point, Mumbai- 400 021.

**3. Terms & Conditions :**

- (i) EMD of Rs.10,000/- (Rupees ten thousand only) for Skoda Superb in the form of Demand Draft/ Pay Order only drawn in favour of "IFCI Ltd." payable at Mumbai must be enclosed with the bid(s). Bids without EMD will not be considered.
- (ii) The successful bidder will be required to deposit the bid amount by way of Demand Draft/ Pay Order in favour of "IFCI Ltd.", Mumbai within **7 days** from the date of acceptance of the bid by IFCI.
- (iii) Bids below the Reserve Price will not be considered.
- (iv) The highest bidder (H-1) will be called successful bidder and second highest bidder will be called second highest bidder (H-2).
- (v) EMD of the successful bidder shall be adjusted against the quoted price.
- (vi) EMD shall be forfeited if the successful bidder fails to honour the bid. Thereafter, H-2 bidder will be given the choice of successful bidder subject to H-2 bidder matches the amount (quote) of H-1 bidder. The EMD of unsuccessful bidders shall be returned after declaration and approval of successful bidder on file.
- (vii) The delivery of the sold vehicle will be arranged only after the successful bidder makes entire payment and submits documentary evidence in support of residential status, viz.
