- II. All the documents required to be submitted by the buyer(s), as prescribed in the RFP dated December 12, 2018, will be submitted in the bid(s) through intermediary (ies) also.
- III. The bid(s) through intermediaries may contain a fee of the intermediary, however the net realisable amount per share, after deducting the intermediary's fee, should be equal to or more than the Minimum Reserved Price, i.e. Rs.810/- per share, mentioned in the RFP dated December 12, 2018. Clear demarcation, in this regard, should be additionally stated in Annexure II of the Bid as per following details:

Point No. VI (additional point in case of bid(s) through intermediary) of Annexure II
of the bid, as prescribed in the RFP dated December 12, 2018 -

"Net Bid Price Per Share (NBPPS) = Total Price quoted per share - Fee of the Intermediary Per Share."


- IV. In case of bid(s) through intermediaries, the Gross Amount, including Fee of the Intermediary shall be payable before transfer of shares. The due fees of the intermediary shall be refunded (by IFCI) after completion of the assignment, up to the satisfaction of IFCI, after deduction of applicable TDS on raising a valid GST invoice by the intermediary.
- V. The ranking of the bids through intermediaries will be on the basis of **Net Bid Price Per Share (NBPPS)**.
- VI. The condition of EMD shall prevail, as prescribed in the RFP dated December 12, 2018, for the bids through intermediaries also.
- VII. The date of submission of bids is extended to January 22, 2019, as following :
