- 2. The query wise response to the RTI Application is as under:-
 - In response to query no.1, the information is made available periodically on IFCI's website. Accordingly, please refer to the website of IFCI Ltd. i.e. www.ifciltd.com
 - II. In response to query no.2 to 3, only that information which is available on the records of the public authority, can be accessed through RTI Act. The CPIO is not supposed to give replies to any hypothetical queries or give opinion or do research work. Since the queries are vague in nature, the same are disposed, accordingly.
- III. In response to query no.4 & 5, only specific information can be sought as per the provisions of the RTI Act, 2005. Sec 2(j)(1) of the RTI Act provides for the inspections of the records of the public authorities and the information which are not exempt as per the provisions of the RTI Act may be sought by inspection of records.
- IV. In response to query no.6 & 7, no such data is maintained by IFCI Ltd.
- V. In response to query no.8 to 11, only specific information may be sought under the provisions of the RTI Act. The CPIO is not supposed to do research work or resolve the issues or respond to the hypothetical queries. Further, all the matters relating to disciplinary proceedings are conducted through the provision of IFCI's Staff Regulations, 1974 which is available on the website of IFCI Ltd.
