1. If the EWS quota is struck down by the Supreme Court of India in the current case, will then the people who got government job or jobs in SIDBI/RBI/SEBI by clearing exam and through using reservation under EWS quota will loose their jobs ?
2. If the EWS quota is struck down by the Supreme Court of India in the current case, what will be the negative consequences if any, for the people who has secured government job or jobs in all India finance institutions like SIDBI/NABARD? If the EWS quota in any case is struck down, then shall these people who are from EWS category and secured job through in SIDBI/Banks/NABARD through EWS quota will loose their job?
3. How many people are employed as a permanent government employee in government departments and are from EWS category?
4. How many people from EWS category are employed as permanent employees in PSBs & PSUs & RBI & AIFIs & SEBI ?
5. If this ministry is not the right one to ask these questions , which is the most suitable authority for answering these questions ?
