Re: Sanction of Family Pension to Shri Radhey Shyam Agarwal, H/o Late Smt. Kamlesh Agarwal

Smt. Kamlesh Agarwal, ex-Assistant Manager, expired on 07.01.2023. She had nominated her husband, Shri Radhey Shyam Agarwal to receive family pension. We have now received the request from him for sanction of family pension along with the following documents: -

Death Certificate of Late Smt. Kamlesh Agarwal i.

Formal application for grant of family pension in Form 9 ii.

Affidavit in Form B as stipulated in Pension Regulation iii.

2. Family pension is payable to him from 08.01.2023 till death or remarriage. As per Chapter VI (32) (4) of IFCI Pension Regulations, 1993, family pension will be calculated as under:

"In the event of death after retirement the family pension at twice the ordinary rate of family pension or @ 50 per cent of the pay last drawn, whichever is less, shall be payable from the date following the date of death for a period of 7 years or till the deceased employee would have attained the age of 65 years, whichever is earlier, provided that the amount of enhanced family pension as above shall not exceed the normal pension admissible on retirement".

Further, as per clause 32 (5) of IFCI Pension Regulations, 1993:

For employees retired before 1st November 1993 -

Pay Range	Rate of Family Pension per mensem
Up to Rs. 1500	30% of pay, subject to a minimum of Rs. 375 per month
Rs. 1501 to Rs. 3000	20% of pay, subject to a minimum of Rs. 3/5 per month
Above Rs. 3000	15% of pay, subject to a minimum of Rs. 600 per month and maximum of Rs. 1250 per month

For employees retired on or after 1st November 1993 –

 - ii. In terms of the provisions of Pension Regulations relating to family pension mentioned above, Shri Radhey Shyam Agarwal is eligible to draw family pension at Rs. 1327/- plus applicable DR from 08/01/2023 onwards till his survival or remarriage, whichever is earlier.
