- 1) Please refer to the aforesaid application filed under the provisions of the RTI Act, 2005.
- 2) In response to query no.1, it is stated that the date of opening of Deposit Account by IFCI with Life Insurance Corporation of India (LIC) for purchasing of annuities toward payment of pension, family pension and Dearness relief on pension to the pensioners covered under IFCI Pension Regulations,1993 is 05/05/1999 and for those covered under LIC Group Superannuation Scheme is 31/03/2009.
- 3) In response to query no.2, it is stated that the queries are vague. However, IFCI contributes in LIC account on account of enhancement in DR i.e.in February and August every year and for any other shortfall in the fund/deposit maintained with LIC. Further, for LIC Group Superannuation Scheme, said amount is transferred to LIC every month, for all the employees registered under the scheme.
- 4) In response to query no.3, it is stated that the queries are vague. However, IFCI has purchased annuities for payment of Pension, Family pension, enhancement of DR and restoration of pension. Further, for those covered under LIC Group Superannuation Scheme, IFCI contributes for each employee for pension, which is paid post superannuation of employee.
