**Sub: Information sought under RTI Act, 2005.**

Please refer to your RTI Application dated 09/03/2022 under RTI Act, 2005 received by IFCI Ltd. on 17/03/2022 (at New Delhi), seeking certain information under the provisions of the act.

2. The query wise response is as under:-

- I. In response to query no.1 of your RTI Application, the name of the Bond Holder w.r.t. Folio No. - 5336140 is Ranajoy Raychaudhuri.
- II. In response to query no.2 of your RTI Application, the Bond was closed in the year 2003 and It is the Bond Holder who is required to deposit the original bond for the purpose of claiming the redemption amount.

Further, IFCI had exercised the call option for early redemption of bonds on 6<sup>th</sup> December 2003 and the interest has ceased to accrue thereafter. Since some of the bondholders had not surrendered the bond certificates despite repeated notices by IFCI through advertisements and letters, in the interest of the bondholders, it was decided in November 2010 to send the redemption warrants at the addresses available as per our records to all the registered bond holders without insisting for surrender of the bond certificate (s).

Accordingly, redemption warrant no.456335 dated 01/12/2010 for Rs. 26216/- was issued and dispatched to the Bond holder but it was unpaid. In case, the Bond Holders wants to claim the redemption, he is required to provide the following documents to MCS SHARE TRANSFER AGENT LTD F-65, 1<sup>ST</sup> Floor, Okhla Industrial Area, Phase-I, New Delhi-110020 Ph. 41406149-6152 :-

- Bond Certificate in Original.

- Cancelled Cheque (For Neft Purpose) Bondholder.
- If Bond holder is expired than send the Death certificate.
- If there is any second holder/nominee than send all self-attested document of second holder/nominee.
