Family pension is payable to her from 03/08/2020 till death or remarriage. As per Chapter VI (32) (4) of IFCI Pension Regulations, 1993 family pension will be calculated as under:

"In the event of death after retirement the family pension at twice the ordinary rate of family pension or @ 50 per cent of the pay last drawn, whichever is less, shall be payable from the date following the date of death for a period of 7 years or till the deceased employee would have attained the age of 65 years, whichever is earlier, provided that the amount of enhanced family pension as above shall not exceed the normal pension admissible on retirement".
