Please refer to your above RTI Application seeking certain information under the provisions of the RTI Act, 2005.

2. The query wise response to your RTI Application (on the basis of comments/information received from concerned dept./ regional office) is as under:-

- I. In response to query no.1 & 2 of your application, the information may be treated as "Nil" from our side as no such notice is received.
- II. In response to query no.3 & 4 of your application, IFCI Ltd. had assigned the debt in M/s Sima Hotels & Resorts Ltd. in favour of M/s Alchemist Asset Reconstruction Company Ltd. vide deed of assignment dated 13/10/2014. As per the provisions of the SARFAESI Act, 2002, on acquisition of the debt, all the rights of a Bank or F.I qua the acquired debts/financial assets vests in favour of the asset reconstruction company. The disclosure of such information which affects the competitive position of the asset reconstruction company is protected under Sec 8(1)(d) of the RTI Act, 2005. Your queries are replied, accordingly.
- III. In response to query no.5 of your application, the information may be treated as "Nil" as no such information qua the said joint decision is available on the records.
- IV. In response to query no.6 of your application, the said details are not available as post assignment of debt in 2014, all files and documents pertaining to the litigation in the matter was handed over to M/s Alchemist Asset Reconstruction Company Ltd.

Further, in addition to the present RTI Application, we have also received another RTI Application (with same queries) on 08/06/2022. Since the RTI Application seeks same information, the said RTI Application along with postal orders are being returned along with the present reply.
