- The query wise response to your RTI Application (on the basis of 2. comments/information received from concerned dept./ regional office) is as under:-
 - In response to guery no.1 & 2 of your application, the information may be treated as "Nil" from our side as no such notice is received.
 - In response to query no.3 & 4 of your application, IFCI Ltd. had assigned the debt 11. in M/s Sima Hotels & Resorts Ltd. in favour of M/s Alchemist Asset Reconstruction Company Ltd. vide deed of assignment dated 13/10/2014. As per the provisions of the SARFAESI Act, 2002, on acquisition of the debt, all the rights of a Bank or F.I qua the acquired debts/financial assets vests in favour of the asset reconstruction company. The disclosure of such information which affects the competitive position of the asset reconstruction company is protected under Sec 8(1)(d) of the RTI Act, 2005. Your gueries are replied, accordingly.
 - In response to query no.5 of your application, the information may be treated as III. "Nil" as no such information qua the said joint decision is available on the records.
 - In response to guery no.6 of your application, the said details are not available as IV. post assignment of debt in 2014, all files and documents pertaining to the litigation in the matter was handed over to M/s Alchemist Asset Reconstruction Company Ltd.
