Please refer to your captioned application seeking certain information under the provisions of the RTI Act, 2005.

2. The query wise response to your RTI Application is as under: -

- I. In reference to query no.1, IFCI Ltd. (formerly Industrial Finance Corporation of India) was set up in 1948 under IFC Act, 1948. Later on it became a Company as per the Companies Act and presently, IFCI is a Non-Banking Finance Company (NBFC-ND-SI) and a Govt Company. The details of the departments and their respective functions are available on website of IFCI Ltd. (link-<https://www.ifciltld.com/2021/RTI%20department%20wise%20information-22.11.2021.pdf>).
- II. In reference to query no.2, the copy of the MOA & AOA, IFCI Ltd. may please be obtained from IFCI Ltd. after depositing a fee of Rs.152/- (Rs.2 x 76 = 152) as per the provisions of Rule 4 of the Right to Information Rules, 2012.

Accordingly, in term of Section 149(6)(a) of the Act, the power to appoint Independent Directors on the Board of IFCI, vests with the Ministry Administratively in-charge of the Company i.e. Department of Financial Services, Ministry of Finance, Govt. of India.
- V. In reference to query no.5, the query is vague and not clear. The employees of IFCI Ltd. are employed as per the provisions of IFCI's staff Regulations, 1974. The said regulations are available on the website of IFCI Ltd. (RTI Page).
- VI. In reference to query no.6, since the said query is vague and not clear, we are unable to respond to said query. Please also note that as per the provisions of RTI Act, 2005 only specific information may be sought under the said act.
