As I have closed my account at Chennai central co-op bank, i requested them to issue me a fresh cheque to my saving account at SBI, in favour of [REDACTED] State Bank of India. I have also enclosed a copy of the cheque for their reference or I have even suggested them to transfer the</p>			

amount through NEFT. On top of all these I have sent the physical letter to Registrar of KFin Technologies Pvt. Ltd. (A unit of IFCI Infrastruture Bonds Series IV) through speed post Viz Speed post Ref no. ET128839146IN dated 07/03/2022. Despite of these reminder through email and physical mail, till now i have not received any positive reply regarding the amount. Moreover, I have been levied income tax around Rs.2300/- by the IFCI authority for the amount which I have not received yet. Added i have to pay difference tax @ the rate of 20% for the amount not paid by IFCI after a lapse of 5 Months.
