**Sub: Information sought under RTI Act, 2005.**

Please refer to your RTI Application no. IFCIL/R/E/20/00029 dated 11/09/2020 seeking certain information under the provisions of the RTI Act, 2005.

2. In this regard, as per the inputs received from the concerned Section/Dept., the response to your queries in seriatim are as under:-

- I. In response to the query no. 1 of your application, as per the provisions of Sec 2(f) of the RTI Act, 2005, only those information which exists on the records of the public authority is accessible as per the provisions of the act. However seeking reasons and clarifications does not fall within the ambit of Information as per Sec 2(f) of the act. The query is disposed off, accordingly.
- II. In response to the query no. 2 of your application, the existing pay scales of IFCI are based on pay scale effective in Reserve Bank of India from 01.11.2007 to 31.10.2012 of RBI.
- III. In response to the query no. 3 of your application, the proposal for pay revision in IFCI Ltd. w.e.f. November, 2013 (01/11/2013) has been submitted to Department of Financial Services, Ministry of Finance.
- IV. In response to the query no. 4 of your application, there is no specific head by the name "conveyance allowance" that is paid to Officers in IFCI Ltd.
- V. In response to the query no. 5 of your application, the CPIO is not supposed to create or interpret the information or reply to the hypothetical questions. Since the query raised is hypothetical in nature, the query is disposed off, accordingly.
