Please refer to your captioned application seeking certain information under the provisions of the RTI Act, 2005.

2. In this regard, the response to your queries in seriatim is as under:-
 - I. In response to the query no.1 of your application, the desired information w.e.f. 2003 onwards is appended with the present reply.
 - II. In response to query no. 2, 3, 5, 8 & 9 of your application, the information sought by you does not falls within the definition of "Information" u/s 2(f) of the RTI Act, 2005 as seeking the opinion/reasons/clarification from the CPIO is not covered within the said definition and as such not accessible under the provisions of Act.
 - III. In response to query no. 4,6,7 & 10 of your application, the definition of "Information" u/s 2(f) of the RTI Act, 2005 does not include within its fold, answers to the question "why" which would be the same thing as asking the reasons or justification for a particular thing. The public information authorities cannot be expected to communicate to the citizens, the reasons why a certain thing was done or not done in the sense of a justification because the citizens makes a requisition about the information.
