Please refer to the captioned RTI Application filed under the provisions of the RTI Act, 2005.


2. The query wise response to your RTI Application is as under:-

- I. In response to query no.1 to 4 of your application, the RTI Application qua query no.1 to 4 had been transferred to the CPIO, IVCF Ltd. as per the provisions of Sec 6(3) of the RTI Act, 2005 vide letter 19/04/2021. The copy of the said letter is enclosed.
- II. In response to query no. 5 of your application, Your reference is invited to the provisions of Sec 2(j) of the RTI Act, 2005 which provides that the "Right to information" means the right to information accessible under the said act which is held by or under the control of any public authority. In other words, only the information which is exclusively held and controlled by a public authority is accessible under the provisions of the act.

Accordingly, since the FIR had been lodged by Central Bureau of Investigation, you may approach the said Public Authority for obtaining the status of the FIR 1082 dated 29/11/2018 as stated in your application. Further, for obtaining the status of the cases pending before the Hon'ble Court, you may apply to the concerned Court as per the procedure prescribed by the said Court for obtaining the information w.r.t. pending or disposed off cases as per law.
