A reference is invited to your letter no. IFCI/Estt./FS/KCP/2018- 180613001 dated 12.06.2018 vide which partial financial dues had been paid and also the undersigned's letter dated 18th November 2020.

An amount of ₹ 20,000.00 had been reflected in the bank account on 03.02.2021. Further an amount of 20,000.00 had also reflected in the account on the same day. The bank, on enquiry confirmed that the payment has been made by IFCI New Delhi. Even after a wait for more than one month the undersigned has yet to receive an official communication in this regard. It appears the payment has been made towards part payment of PF dues and refund of retention money.
