- II. In response to query no.2, In IFCI in case of death of an employee, payment against terminal benefits is done as per extant guidelines. Further, for employee who have died due to COVID-19, apart from terminal benefits, an ex-gratia amount has also been paid to the family member of the deceased.
- III. In response to query no.3&4, As per document handling & retention policy, the personal files/records pertaining to last five years shall be stored. During last 5 years, no death has happened due to accident in the course of performance of duties.
- IV. In response to query no.5, the information may be treated as "NIL".
- V. In response to query no.6, the information may be treated as "NIL" as in IFCI, CCS(EOP) Rule 1939 is not applicable.
