Dear Sir,

Sub: RTI Application no. DOFSR/R/T/22/00008 dated 03/12/2021- Letter no. F.No. 20/53/2022-IF-I dated 10/01/2022- Information as per RTI Act, 2005.

Please refer to your captioned application and letter received from the Department of Financial Services, MOF, GOI whereby the RTI Application was transferred to IFCI Ltd. as per the provisions of the RTI Act, 2005.

- 2. In this regard, the query wise response to your RTI Application is as under: -
  - I. In response to the query no.1 of your application, the judgment/order passed in CP(CAA)/2779/MB/2018 dt. 27/09/2018 is available on the website of Hon'ble National Company Law Tribunal, Mumbai Bench. The information, which is already available in the public domain, cannot be accessed through the provisions of the RTI Act, 2005. The query no.1 is replied, accordingly.
  - II. In response to the query no.2 of your application, your reference is invited to the decision of the Hon'ble Bombay High Court in the matter of "Dr. Celsa Pinto Vs The Goa State Information Commission" and the operative part of the said judgment is reproduced herein below: -

"The definition cannot include within its fold answers to the question "why" which would be the same thing as asking the reason for a justification for a particular thing. The Public Information Authorities cannot expect to communicate to the citizen the reason why a certain thing was done or not done in the sense of a justification because the citizen makes a requisition about information. Justifications are matter within the domain of adjudicating authorities and cannot properly be classified as information."

Since seeking/asking justifications are not covered within the definition of Information as per the act, the query is replied, accordingly.

- III. In response to the query no.3 of your application, it is also informed that pursuant to restructuring of the Existing Outstanding of the Borrower under the 'Resolution Framework for COVID-19-related Stress' dated 6 August, 2020 issued by the Reserve Bank of India, the outstanding dues of Nishta Mall Management Pvt. Ltd. were restructured, and at the time of the restructuring, the outstanding dues were Rs.41.62 crore. Accordingly, the charge created on 24.09.2014 was modified on 02.06.2021.
