Please refer to your captioned RTI Application seeking information under the provisions of the RTI Act, 2005.

2. The query wise response to your RTI Application is as under: -

1) In response to query no. 1 & 2 of your RTI Application, IFCI Ltd. had filed an OA before DRT, Delhi vide OA no.98/2000 before DRT, Delhi and the same was allowed and Recovery Certificate no. 98/2000 was issued in favour of IFCI Ltd. The details of the cases are already available on the website of DRT.

Further, the information, which is already available in public domain, the same cannot be accessed through RTI Act, 2005.

2) In response to query no. 3 of your RTI Application, the recovery proceedings instituted by IFCI Ltd. is still pending before the DRT, Delhi and the information sought pertains to M/s Rajinder Steels Ltd (borrower company) and as such protected from disclosure as per the provisions of Sec 8 (1) (d) & (e) of the RTI Act, 2005.

3) In response to query no. 4 of your RTI Application, the RTI Application pursuant to its receipt was forwarded to the concerned dept. (HR/Vigilance dept.) to provide the details w.r.t. information sought vide query no.4. It is informed by the said departments that no record of staff accountability is available in the account of Rajinder Steels.

4) In response to query no. 5 of your RTI Application, the Board Resolution, as sought, is not traceable in the records available with IFCI Ltd.
