Subject : Information under Right to Information Act, 2005 (RTI Act)
regarding grant of family pension to me after passing away of [REDACTED]

I have to state that after passing away of my husband, Shri S.C. Ahuja, who retired as Private Secretary from the service of IFCI, I was sanctioned family pension at the enhanced rate of Rs.3510/- p.m. from 14-02-2005 to 13-02-2012 and then at an ordinary rate of Rs.1755/- p.m. from 14-02-2012 onwards, vide IFCI's letter No.IFCI/PEN/1068/2005-7592 dated 1st April, 2005 (copy enclosed for ready reference). However, I was not provided with any working sheet/calculation sheet showing the method/basis for arriving at the said sums of enhanced family pension and ordinary rate family pension. **Therefore, I seek following information under RTI Act**, which may please be provided to me within the time schedule prescribed in the RTI Act:-

- (i) Provide me a certified copy of calculation sheet/notings showing working for fixation of family pension paid to me at enhanced rate of Rs.3510/-pm from 14-02-2205 to 13-02-2012 and at ordinary rate of Rs.1755/- p.m. from 14-02-2012, onwards.
 - (ii) Provide me certified copies of –
 - (a) the extracts of relevant Regulation of IFCI Pension Regulations 1993; and
 - (b) the relevant extracts of the Instructions for Implementation of IFCI Pension Scheme containing the *definition of pay for fixation of family pension and payment of Dearness Relief payable on family pension.*
 - (iii) Provide me a certified copy of any other document like HR/Admn Circular etc. whereby the definition of pay for fixation of family pension and payment of dearness relief on family pension was circulated by IFCI among its employees, pensioners and the recipients of the family pension.
 - (iv) Inform me the amount of pay last drawn by my late husband at the time of his retirement which was taken into account for fixation of his pension and the pay scale period during which the said pay fell/pertained.
 - (v) Provide me a certified copy of the Statement/Table showing calculation and fixation of pension granted to my husband after his retirement from the service of IFCI.
