IFCI would like to give the following press release with regard to the case filed by IFCI Ltd. against Reliance Marine and offshore Ltd. and Reliance Naval & Engineering Ltd. before the NCLT, Ahmedabad.

2. At the hearing held on 19th December, 2017 before the NCLT, Ahmedabad, the Tribunal has rejected the application filed by Reliance Naval & Engineering Ltd. seeking a stay of the NCLT proceedings on the ground that the Constitutional validity of Section '7' IBC is under challenge before the Hon'ble Gujarat High Court.

3. NCLT, Ahmedabad has given a time of seven days to the Respondent to file an appeal against the above dismissal of the application.

4. IFCI would like to state that the News Report Items that were published in the edition of 20th December, 2017 are factually incorrect to the following extent:

- (i) None of the lenders of RMOL/RNEL have contacted/approached or spoken to IFCI after the filing of NCLT Petition, suggesting that the matter be solved outside the NCLT Forum.
- (ii) IFCI states that the loan is duly secured by the Corporate Guarantee of Reliance Naval & Engineering Ltd.;
- (iii) IFCI's claim on the amount of debt owed on account of Reliance Marine and Offshore Ltd. is Rs.159 crore, as per the Petition filed by it before NCLT, Ahmedabad and not Rs.60 crore.

Further, IFCI would like to state that the matter is currently sub-judice and the case is posted on 11th January, 2018.
