**3. Terms & Conditions :**

- (i) EMD of Rs.65,000/- (Rupees sixty five thousand only) may be prepared in the form of Demand Draft/ Pay Order drawn in favour of "IFCI Ltd." payable at New Delhi must be enclosed with the bid. Bids without EMD or any other form i.e. cheque or cash etc. will not be considered.
- (ii) The successful bidder will be required to deposit the bid amount by means of Demand Draft/ Pay Order in favour of "IFCI Ltd.", New Delhi within **7 days** from the date of acceptance of the bid by IFCI.
