#### **6. PAYMENT SCHEDULE:**

- 6.1 The EMD of the successful bidder shall be retained towards part sale consideration. The successful bidder shall have to deposit 25% of the sale price (less EMD) by way of demand draft favoring IFCI Ltd. payable at Chandigarh or through RTGS (RTGS details can be obtained from IFCI's office)
